COMMUNITY ROOMS RE-OPENED

We have re-opened the Community Rooms at Riverview Manor, Infantino Towers, and Winter Street. The Community Rooms require a \$50 refundable deposit. The funds are given back once the rooms are cleared as having no damage. If you want to view our **Community Room Policy, click here.**

SECURITY CAMERA UPGRADE PROJECT UNDERWAY-

The Authority received a \$250,000 Safety & Security Grant from HUD to implement Security Camera Upgrades at all development sites to improve the safety and well-being of residents. This project was recently awarded to M&B Electric who will be performing the camera upgrades in the next few months.

MOVE TO WORK DESIGNATION

The Housing Authority was recently granted a Move to Work Designation. It's a 20 year designation that will allow the Housing Authority to develop policies and procedures to respond to local challenges. This includes providing family self-sufficiency programs to residents, improving housing choice, and enabling flexibilities to better meet resident needs between public housing and section 8 programs. More information will become available through a public process plan in the coming months. There were 14 agencies awarded this designation countrywide and we are proud to be one of them!
